Preamble

SHRI JAI NARAYAN P.G. COLLEGE, LUCKNOW-226001, U.P has submitted an application dated 09.08.1997 for starting B.P.ED course. The application submitted by the institution, VT Report and documents along with the application of the institution were considered by NRC and decided to issue permission for starting B.P.ED course for the session 1998-1999 vide order no. NCTE/NRC/F-3/13/98/5070-75 dated 11.12.1998 with an intake of 60 students in B.P.ED Course.

In the meanwhile a complaint was received against the institution alleging that the institution had admitted an excess of 30 students violating the NCTE Act Rule and Regulation. Based on enquiry and inspection and VT Report it was decided to fix the intake of 60 students and inform accordingly to the concerned university vide letter no NCTE/NRC/F-3/UP-284/320/99/12897 dated 3.11.99. Aggrieved by the direction of the NRC NCTE, the institution preferred an appeal before the appellant authority. The appellant authority by order no F-42-7/2000 Appel/2131dated 20.6.2006 had confirmed the decision of the NRC NCTE in response to the notice dated 28.6.2000.

The institution submitted a reply vide letter dated 31.5.2008. The original file of the institution and the reply submitted by the institution were placed before NRC in its 131st meeting held on 9-11 August 2008. Based on the decision of 131st meeting the letter of intent prior to recognition letter no. NRC/NRC/F-7/UP-320/2008/57890 dated 21.8.2000 was issued to the institution. There after the matter again was placed 132nd meeting in order to confirm the decision taken in earlier meetings and order issued during the 1998. Now the institution had existed before the commencement of the 1993 Act, it is mandatory to bring the institution under the provision of the NCTE Act, Rules and Regulation. Hence, the following order:

ORDER

NOW, THEREFORE, in exercise of the powers vested under Section **15(3) (a)** of the NCTE Act, 1993, the Northern Regional Committee hereby confirms recognition/permission granted already to **SHRI JAI NARAYAN P.G. COLLEGE, LUCKNOW-226001, U.P** as mentioned above for conducting **B.P.Ed. Course** of Secondary- PE **(level)** of **one year** duration with an annual intake of **60 (sixty)** students subject to fulfillment of the following condition:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

(iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

4. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

5. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.
